Treasurer's Report:

MARC 2009 Annual Meeting:

The MARC 2009 annual meeting will be held at the Grand Traverse Resort, Acme, Michigan (near Traverse City), June 14-17, 2009. Registration on the new website will be open in February. The proposed theme is "Moving to a Carbonless Economy."

New Business:

President Martinez proposed that MARC continue its tradition of providing a \$1,000 stipend per state commission to attend the MARC annual meeting. A motion was made to approve a \$1,000 stipend per state commission for the annual meeting by Commissioner Lemmie. Commissioner Hanson seconded the motion. The motion passed.

MARC by-laws require each state commission to pay an annual membership fee to MARC, however, that fee is traditionally waived by vote. A motion was made by Commissioner Moffet to waive the annual membership fee. Commissioner Reha seconded the motion. The motion passed.
